### **OPAL Research**

OPAL investigator **Dr. Alice Medalia** recently began a new R01 project entitled "Efficacy of Personalizing Cognitive Remediation for Schizophrenia by Targeting Impairments in Early Auditory Processing". The study intends to enhance CR outcomes in schizophrenia spectrum disorders by identifying a scalable approach to optimizing and personalizing treatment. By facilitating a better understanding of EAP as a neurobehavioral marker, sensory processing as mechanism of change, and the essential CR treatment targets for EAP impaired CR participants , the 4 year study will inform improved clinical decision-making and guide clinical judgment about how to best provide cognitive training.

**Dr. Deidre Anglin**, Associate Professor of City University of New York, was awarded an OPAL pilot project for 2021. The goal of this pilot project is to identify how anti-Black racism shapes social determinants (social, economic, and environmental conditions) for Black individuals with a first episode of psychosis (FEP) in ways that hinder recovery. The use of photovoice, a qualitative method that uses photos and accompanying narratives to reflect personal and community strengths and challenges, will enhance the ability to learn something new about optimizing early intervention from the perspective of Black young people in the community.

## **Voice from Stakeholders Advisory Board Committee**

In addition to our national Stakeholder Advisory Board committee (Ann Marie T. Sullivan, Ruth S. Shim, Brian M. Hepburn, Debra Joy Perez, Sherry Glied, Patricia E. Deegan), we have added new local provider (Mansour (Max) Banilivy, Michael Blady, Katariina Hoaas, Virna Little, Nadjete Natchaba, Jeanie Tse) and local consumer (Wendy Burch, Cory Muraglio, Garrett Smith, Tony Trahan, Carlton Whitemore) stakeholder advisory groups to better understand issues facing providers and consumers. Meetings were held quarterly to get input on what directions we should take and on how to make sure our interventions have real-world feasibility and applicability. Discussions especially on how COVID-19 is changing the delivery of health care and what is not going so well for services were highly focused in recent meetings to help OPAL Center best respond to the pandemic and to the additional evidence of injustice and disparities in our country.
